Mr Roberts also stated that the CCB has the responsibility to obtain from the Community what they want the Council to do in the area.

The Executive stood down and Greg Roberts took the Chair for the election.

Reports

- a. Treasurers report presented and accepted
- b. David Wilson and Robyn Kerves reported on the Combined CCB meeting.

Council is producing a new Local Environmental plan and there are many issues that must be addressed. These issues include a blanket height restriction throughout the Shoalhaven and also the fact that some Councillors leave the meeting area as a result of a possible conflict of interest so that a consensus cannot be achieved.

Cr Robert Miller is chairing a Height of Buildings committee to investigate these issues for Shoalhaven Council.

- c. The Lake edge cabins- David Wilson reported that Council and LPMA are to get together to solve the problem. He explained that through FOI it was discovered that what was actually built at the Lake Conjola Holiday Haven Caravan Park was not what was on the approved application. It was moved by B Wood and seconded by L Cairns that :- Lake Conjola Lakecare Association does not enter into any further correspondence over this matter until the Association finds out what is happening about the Section 68. Motion carried
- d. SSNR and FP meeting: David Wilson, Robyn Kerves, and Elaine Caswell reported on this meeting

The emergency opening of the Lake on the Northern side was as a result of a rise in the height of the Lake. It was stated that members of the Association had met with a representative from Council on site and discussed an opening towards the southern side of the Lake following a meeting the day before in Ulladulla. At that on site meeting it was agreed that the next opening should be towards the Southern side if the Little Terns had moved from the beach. It was suggested that Council consult better with both the local Community and other interested organisations to ensure that any

future openings are better coordinated. It was pointed out that Lake Conjola is flowing faster after a check of the flow meter and it was also stated that the Association should work to dismiss any urban myths that are held in the local area. One attendee stated that perhaps Council should abandon any future artificial openings of the Lake.

- e. Roads and Infrastructure:- Robyn Kerves rang Graham Clunis from Shoalhaven City Council re the state of Lake Entrance Road and it was pointed out in the meeting that Council do the road base work and Downer EDI only put a surface on top of it.
- f. Only 1 DA had been received and that was put on display to the members present.

Planning and Development:-For approximately 3 years the State Government Housing code has allowed 10 day planning approvals within certain restrictions. This has now been extended to include most bushfire prone areas. The State Government has requested that all Councils upgrade their input into LEPs and DCPs.

g. How often should Lake Conjola Lakecare meetings be held? After general discussion it was decided that they be bi-monthly

General Business

There is a Community Notice Board outside of the Fishermans Paradise Fire Shed and hopefully the Association can put notices of future meetings up there. There is to be meeting at Fishermans Paradise Hall on either the 1st or 2nd Wednesday in May at 1pm to discuss the control of the Fishermans Paradise Hall. Contact Leo Floyd on 44565894

Motion:- Lake Conjola Entrance Road, the Association contact Council to have the road upgraded. Carried.

What happened to the proposed pram/cycle way in Lake Conjola Village. It was pointed out that the residents on the side of the road that the pram/cycle way was on would have to pay for its cost.

The name Lake Conjola Lakecare does not include Fishermans Paradise and other surrounding areas. It was pointed out that the name cannot be changed until the next Annual General Meeting and all members should consider a possible future name.

It was stated that the Council has an attitude that Lake Conjola is the centre of the area, what about Fishermans Paradise? There is no pathway down Fishermans Paradise Road and no mowing done consequently residents have to walk on the roadway in order to get to the highway to catch the bus.

It was suggested that the road through the Lake Conjola Holiday Haven Caravan Park should be upgraded urgently.

- 2. Leo Floyd gave a report on the progress of the path/cycleway from Fishermans Paradise to the Highway. To date the group have organised:-

The work is hoped to be commenced in July 2011

Leo then explained the problems that they were experiencing organising a meeting room for the Fishermans Paradise group to meet in and was still in negotiations over the cost of a venue.

- 3. Correspondence:-Presented and accepted
- 4. Treasurers report :- Current balance \$338.38 report accepted E Caswell, R Kerves
- 5. The Lake Conjola Path/cycleway:-David Wilson gave a report on this matter and it was proposed that there be a single issue meeting

to be held in relation to both this and the Fishermans Paradise pathway. This was agreed upon and the meeting is scheduled for Saturday 9th. July at 11am. A letter drop and notices are to be organised to publicise the meeting.

- 6. The CCB web page has been set up by David and it is http://lcla.weebly.com
- 7. Clnr R Miller arrived at 7.55pm
- 8. Community Transport:- Robyn gave a report on the transport available within the CCB and encouraged those present to make senior citizens aware of the numerous transport facilities.
- 9. Subsidence on the Foreshore near the Deep Water Caravan Park:- Elaine told the meeting that the CCB had been made aware of the

possible subsidence in this area and as a result she had contacted Ray Massie at Council. As a result of that communication the meeting voted to send a letter presented by David to Russ Pigg, Ray Massie and the local Councillors supporting the proposed remediation work in the area.

10. The Foreshore at the entrance to the Lake:-David explained that LPMA had undertaken an audit on the Holiday Haven Caravan Parks

Ken explained that in relation to the road through the caravan nobody seems to want to take responsibility for its upgrade. It was agreed that

Ken should send a letter to Council regarding resurfacing the road through the park. Clnr Miller suggested that the Association contact Penny Lumb for assistance in relation to any grants that may be available for improvements in the CCB.

- 11. Boat Ramps:- Ken gave a report on the boat ramps within the CCB and it was made obvious that very little had been done to them and most of them needed urgent repair and or maintenance. It was suggested that there be a single issue meeting held in September in relation to this matter. It was also pointed out that the Dept. of Fisheries has grants that organisations can access in order to upgrade boating facilities.
- 12. Infrastructure:- The next major issue that the CCB should tackle is the poor state of the roads throughout the CCB.
- 13. DAs :- Only 2 applications had been made within the CCB and David stated that neither caused any great concerns for the Association.
- 14. LEP :-David reported that the agreement regarding the building heights allowed within the CCB will be advertised soon
- 15. General Business: 50kph signs should be put up throughout the CCB as many vehicles are travelling too fast in the urban area.

Volunteers needed to assist with the nesting birds on Conjola Beach when there is a threat of dangerous tide and weather conditions. Col Ashford will put anybody interested in volunteering in contact with the appropriate people.

Concern was raised in relation to the parking of boats on the water close to the Lake Entrance where many people choose to take their families or a swim. It was noted that the Southern Shoalhaven Natural Resource and Floodplain Management Committee had also looked at this issue and a NSW Maritime representative had stated that a no boating area would be designated within that area, and it was noted that nothing further had resulted from that. The matter should be followed up by the representatives on that Committee at their next meeting.\
